Te Tiriti o Waitangi is our country's foundational document. It provides a framework for partnership that champions mana ōrite | equality, mahi kotahitanga | working together and rangatiratanga |chieftainship.

Te Tatau o te Whare Kahu ki Hine Pae Ora | the Aotearoa Midwifery Project has led us to a gateway. This revised scope is whānau centred, inclusive and affirms and enables kahu pōkai |midwives to practise in ways that meet the needs of the whānau they work alongside.

I want to acknowledge that, in these uncertain times, the Council is asking you to review the Scope of Practice and to consider what this means for you as practitioners. Before you provide your feedback, please take the time to explore and discuss the revised Scope using the resources that can be found here.

As part of the process of seeking feedback, we will host a number of wānanga and webinars. These will be scheduled towards the end of March and we will let you know the dates as soon as they are confirmed.

Once again, I want to thank you for taking the time to review and consider the revised Scope of Practice and to provide us with your feedback and questions.

APC update

We have again reached the time when Annual Practising Certificates need to be renewed.

Remember, all midwives who engage in practice need to have a practising certificate. Practise is not just clinical practice but also education, quality improvement, regulation, professional policy advice etc... Any role that requires you to use your midwifery knowledge and skills and that impacts on public safety. Midwives are required to hold a practising certificate if they are providing antenatal education or lactation services because these are both skills that sit under the midwifery scope of practice.

The Council acknowledges that there have been challenges completing face to face education during 2021 and that this may continue during 2022. If you are overdue a requirement by more than 4 months, please email us education@midwiferycouncil.health.nz to discuss.

If you are not going to practise, you will need to log in to MyMCANZ complete the non-practising process and change your status to 'Non practising'. Log into <u>MyMCANZ</u> to complete your application from March 4 onwards.

Register review

One of the recommendations from the Council performance review was that it continue to tidy up the Register.

One action from this is for the Council to establish a regular review of the Register. The processes for this are clearly outlined in the HPCA Act. After APC renewals ends the Council will contact all midwives who held an APC in 2021-2022 to ascertain if they are practising. Midwives who are not practising and who have not renewed will be given options regarding ongoing registration. The Council will also be in contact with those midwives on the register who have not held an APC for a number of years regarding the cancellation of their registration. Further details about these processes will be provided to those midwives who are impacted. The Register needs to be an accurate reflection of practising and non-practising midwives who are based in Aotearoa | New Zealand.

Recertification changes

After considering feedback about proposed changes to the Recertification programme, the Council met in December 2021 and agreed to implement both proposals:


- That the Council mandates the content of the continuing education component of the Recertification Programme for midwives.
- That the Council makes completion of the course Integrating Abortion Care into the Midwifery Scope of Practice mandatory for the period 1 April 2022 – 31 March 2023

The Council also agreed to ask the schools of midwifery to change the name of the course so that it more accurately the content – the mandatory course is now called "Introduction to the Abortion Legislation and Midwifery Roles and Responsibilities"

In 2022-2023 all midwives will be required to complete the short course. This will be part of their minimum continuing midwifery education requirements. The Council wants to reiterate that completion of the course will not enable midwives to provide care. It is about understanding the law change. There are no changes to other components of the Recertification Programme at this time.

The Council appreciates that it has been challenging booking onto workshops and acknowledges that this is currently problematic. The Council is aware that a number of providers have developed online learning for the Midwifery Emergency Skills Refresher course with peer review of practical skills. This is encouraged and supported during these times of change.

The Council encourages midwives to ensure that they have added their completed education to their MyMCANZ portal prior to applying for their practising certificate.



Vaccine mandate update

Recent changes to the vaccine mandate now require all midwives who engage in face to face clinical care to comply with the requirements for boosters. Links to the legislation and information about the mandate can be found on the Ministry of Health <u>website</u>.

Voluntary Bonding Scheme 2022 Intake

The Voluntary Bonding Scheme is an initiative run by the Ministry of Health to encourage newly qualified health professionals to work in the communities and specialties that need them most, and to retain essential health professionals throughout Aotearoa.

Those on the scheme can receive payments to help repay their student loan or as top-up income for those without a loan. If you are a new-graduate midwife:

- who completed undergraduate studies in 2021 (or early 2022), and
- you intend to work in an eligible hard-to-staff community for at least three and up to five years,

you may be eligible to register for the 2022 Intake of the Scheme.

If your registration is accepted and you meet the terms and conditions, a bond payment of \$10,500 (after tax) is available after the completion of a minimum of three years' service, and up to two additional payments of \$3,500 after a fourth and fifth year. The six-week Registration of Interest period for the Scheme's 2022 intake is open from **14 February to 27 March 2022.** Registration is via an online web-form available on the Ministry's website.

Health Practitioner Disciplinary Tribunal ruling

In October 2021, the HPDT found <u>proven charges</u> involving informed consent, providing misleading information, failing to keep adequate documentation, and failing to adequately explain to the patient what medications she had received during labour against midwife Helen Marie Bakker. The Tribunal ruled this conduct amounted to professional misconduct on Ms Bakker's part.

As a result of the charges being proven, RM Bakker was fined, had to pay costs and was prohibited for supervising midwifery students for a period of 12 months.



Performance Review

Under the HPCA the Council was required to undergo a performance review.

This occurred in December 2021. The report from the

Review can be located on our <u>website</u>. The amount of work that was involved in preparing for the Review was massive and I want to acknowledge the Council staff who all worked together to ensure our review was a seamless success.

There are a small number of recommendations for improvement that we have already commenced working on.

What we have done ..

- Submitted and then presented to the Pae Ora (Healthy Futures)
 Select Committee
- Progressed work on the standards of competence
- Registered a number of Aotearoa graduates and internationally qualified midwives who have entered the workforce
- Attended the Prescribing Safety hui
- Worked on joint standards for prescribing health practitioners
